Pennsylvania Certified Safety Committee Program Offset

The attached exhibit presents participation figures in the Pennsylvania Certified Safety Committee Program for policies written during Policy Years 2004 through 2018.

The PCRB is recommending that a factor of 1.07% be applied to loss costs to offset the credits offered by this program. This is a slight increase from last year's value of 1.02%.
